- Support and advise the International Programs' team on financial and tax issues.
- Review financial clauses in contractual agreements and monitor contracts executed by partner organizations.
- Contribute to the planning of budgets and financial forecasts.
- Analyze financial statements and project reports to optimize steering and monitoring of activities and propose financial adjustments in collaboration with project managers.
- Carry out various financial and tax follow-ups with managers and support them in their financial analysis needs.
- Monitor and update the ERP system for the financial management of International Programs projects.
- Accompany project managers in the use of the ERP and verify the suitability of the tool for the needs of International Programs.
- Check invoices and requests for funds from International Programs and their coding.

- Participate in the preparation and execution of external audit files for partner organizations.



- Collaborate in the development, updating and application of internal controls, policies, and procedures for the organization and more specifically for international programs.
- Support the International Programs team in all matters relating to the financial and administrative management of contracts.
- As required, develop, and deliver financial management training to members of the International Projects team.
- Participate in maintaining an adequate control environment based on risks and suggest any improvements to be made to the environment.
- Assist the interim Vice-President, Finance and Administration (CFO) and the International Programs team in various mandates.
